You become a better consumer, a more informed consumer and this way you're able to ask the right questions when you go in and actually speak to a lawyer about your possible case.

Now, I could sit here and talk for 20 minutes and go into details about what's in the book, but I'm not going to do that. I'm merely giving you a brief overview of what's in the book because I
